4. <u>DISCUSSION</u>

a. Horry County Treasurer Update - Ms. Angie Jones

Horry County Treasurer, Dr. Angie Jones shared that there had been a collateralization issue that impacted the District in 2018 due to no fault of the District's staff and that the Solid Waste Authority had a similar occurrence this year. To resolve any future occurrences, the Horry County Treasurer's office negotiated with its financial institutions to ensure that all deposits under the County's jurisdiction were covered through a "blanket" collateralization agreement.

She also thanked the Board for their service and stated that she John Gardner had a very good working relationship.

b. Horry County Sheriff's Foundation Blanket Drive - Sheriff Phillip Thompson

Sheriff Phillip Thompson addressed the Board regarding the Horry County Sheriff's Foundation Blanket Drive. Sheriff Thompson thanked HCS for their partnership and for sharing this information about the blanket drive on all of the District's media platforms. Sheriff Thompson noted at this time, the Horry County Sheriff's Foundation has collected over 500 blankets and pillows for the children of Horry County.

c. Policy Committee Meeting Report - Mr. Winters

Mr. Winters stated the Policy Committee met earlier today for an organizational meeting. Mr. Winters noted the purpose of the meeting was to look at Board Governance for the purpose of firming up inconsistencies and reviewing potential revisions. Mr. Winters stated the Policy Committee will meet again on January 13, 2020, at 3:00 PM.

d. Joint Facilities/Finance Committee Meeting Report - Mr. James/Mr. Hardwick

Mr. James noted there were four items discussed at the joint Facilities/Finance Committee Meeting held earlier today. Mr. James remarked the designs of the track and tennis courts are on schedule. Mr. James stated the Committee will soon request funding from the Board. Mr. James noted this project should be completed within a year. Mr. Hardwick stated Mr. Gardner was working on providing the Board a more simplified presentation of the fund balance. Mr. Hardwick also noted there was discussion on project end dates and closing out those accounts. Mr. Hardwick noted during the meeting Mr. James made a motion to close all funding 12 months after the substantial completion dates. Mr. Hardwick noted that HCS was preparing to budget for an additional 841 students district-wide. Mr. Hardwick also noted that the personnel allocation formulae was discussed.

e. 2019 SCSBA Legislative Advocacy Conference and Delegate Assembly - Ms. Morreale

Ms. Morreale, Ms. Graham, and Mr. Winters attended the 2019 SCSBA Legislative Advocacy Conference and Delegate Assembly this past weekend. Items discussed during the Conference included teacher and staff workload, class size, staff retention, working with staff to manage student loans, etc. Ms. Morreale noted Mr. Alan Walters, Executive Director of Safety for the Georgetown County School District, is now a member of the State Board of Education representing Horry and Georgetown Counties.

f. Monitoring Report - OE-6 Financial Administration - Mr. Gardner

Monitoring Report OE-6 was presented. Mr. Gardner noted that at the January 13, 2020, Board Work Session, the District's Auditor will be here to present the fiscal year 2019 audit.

g. Monitoring Report - OE-7 Asset Protection - Mr. Gardner

Monitoring Report OE-7 was presented. Mr. Gardner stated we are in compliance.

h. 2020-2021 Budget Assumptions and Parameters - Mr. Gardner

The 2020-2021 Budget Assumptions and Parameters report was presented. Mr. Gardner shared information from this report. Mr. Gardner noted HCS is expecting 841 students this upcoming school year.

i. 2020-2021 Personnel Allocation Formulae - Mr. Gardner

The 2020-2021 Personnel Allocation Formulae report was presented. Ms. Myrick presented and reviewed a slideshow regarding the current formulae. Ms. Velna

Allen addressed the Board regarding the need for an increase in the Guidance personnel and support at the elementary level.
