3. 2021-2022 K-12 HCS Virtual Overview – Ms. Myrick

Ms. Edi Cox along with Mr. Lee James presented an overview of the 2021-2022 K-12 HCS Virtual program, including updated enrollment projections.

Background Information K-12 HCS Virtual

Since 2011

HCS Virtual FLEX (supplemental program for grades 9-12)

Beginning 2020-21

K-12 HCS Virtual (K-12 full-time virtual learning) Hybrid (face-to-face and distance learning)

SCDOE Memorandum (7-17-20) Regarding Public School Re-opening Plans:

To be approved, plans must answer all questions posed in the school reopening survey sent on June 10, 2020, as well as include:

1. A virtual option for all students
 - Districts may choose to deliver their own virtual program, take advantage of VirtualSC, suggest enrollment in one of the public charter virtual schools, or contract the service.

Virtual SC - State Virtual Program

- Supplemental program available to all 9-12 students in the state
- No established K-8 program (currently piloting 6-8)
- Student calendar (start and end dates)
- Caps on enrollment (first come first serve)

K-12 HCS Virtual Course Offerings

- Students enroll in a wide range of courses including College Prep, Special Education, English As a Second Language, Career and Technical Education and Advanced Placement.
- Courses offered in K-12 HCS Virtual closely align with those offered at brick-and-mortar schools.
- Students who attend their brick-and-mortar schools also have access to courses through the HCS Virtual FLEX (supplemental) program.

Typical Instructional Day - Elementary

- In our elementary program, K-12 HCS Virtual students are offered more structure than upper grade levels, but students also benefit from the more flexible schedule K-12 HCS Virtual provides.

- Elementary students receive a minimum of one hour of live direct instruction each day with the whole class. This live instruction is a valuable time to connect with classmates and teachers and get the live instruction needed to learn the skills and be successful in elementary coursework. Additional individualized lessons are scheduled throughout each day to support students in small groups or one on one.
- On average, elementary students spend about 75 percent of their time working on computer-based activities and 25 percent working on hands-on learning activities.
- On average, elementary students spend about 3-5 hours per week for each core course taken and about 1 hour per week for each specials course. This time estimate is a combination of computer-based and hands-on learning activities.

Typical Instructional Day - Middle/High

- In our middle/high program, K-12 HCS Virtual students have greater flexibility with their daily schedules than compared to a traditional school schedule, whether that is in person or online.
- Middle and high school students are offered two live lessons per course each week with the class. These live lessons are based on the lessons due that week. Additional individualized lessons are scheduled to support students in small groups or one on one.
- Students can personalize their schedules to meet their individual needs throughout the day. Students work on each course based on an individualized pacing guide, with direct teacher support and guidance.
- Middle and high school students usually do more work online with fewer offline assignments.

Guiding Considerations for 2021-2022

- Health and safety concerns are likely to impact family educational decisions in the 2021-2022 school year.
- Motivated by success in virtual school setting in the 2020-2021 school year, families are likely to expect a virtual option.
- Based on data from nation-wide polls, approximately ½ of students currently enrolled in virtual programs are projected to continue into next year. Given current K-12 HCS Virtual enrollment trends, projected enrollment for 2021-2022 would be approximately 5,000 students.

- Structures and protocols are in place to provide effective supports for students and staff for the future.
- A sustainable program can be built based on the lessons learned in the 2020-2021 school year and best practices for online learning.

Planning is guided by resources from national organizations and experts in the field of online learning. (*National Standards of Quality, Quality Matters, Digital Learning Collaborative, Virtual Learning Leadership Alliance*) and well-established quality online programs (*Michigan Virtual, Fulton Virtual, VirtualSC, etc.*)

K-12 HCS Virtual 2021-2022

- K-12 HCS Virtual 2021-2022 will be a continuation of this year's program. The structure will remain the same.
- K-12 HCS Virtual will continue to be an option for all students K-12.
- Students will register in the spring of 2021 for the 2021-2022 school year.
- Students will continue to be enrolled in their base school.

4. 2021-2022 K-12 HCS Virtual Program Staffing Formula - Mr. Gardner

Mr. Gardner shared with the Board that on December 7, 2020, the Board of Education was provided the Personnel Allocation Formulae – FY2022. At that meeting, the Board was notified that the formulae did not include HCS Virtual due to the second-semester decision date deadlines.

At the January 11, 2021 Board Meeting, the 2021-2022 Personnel Allocation Formulae for HCS Virtual was presented to the Board of Education. The Board approved the Personnel Allocation Formulae - FY2022 that was previously submitted in December and recommended that staff consider input from the Board regarding the 2021-2022 Personnel Allocation Formulae for HCS Virtual.

Mr. Gardner is seeking Board approval of the 2021-2022 Personnel Allocation Formulae for HCS Virtual. The estimated cost is \$.9 million to \$1.5 million for non-instructional staff. Instructional staff will be funded from base school transfers. Funding Source: CARES Act.
