#### 1. OPENING AND CALL TO ORDER

Board Chair Richardson called the meeting to order at 6:00 PM.

3. **DISCUSSION**

a. **Superintendent's Report**

Dr. Maxey discussed two topics during the Superintendent's Report. First, Dr. Maxey called upon Ms. Allen to provide a report on the return of athletics.

Ms. Allen remarked that fall sports practice will resume on Monday, June 22, 2020, starting with a phased-in approach of football on that date. Ms. Allen noted that this approach would begin with team sports and that a plan was in place for cheerleading, including a two-week process where cheerleaders would learn the routines virtually. Ms. Allen remarked that HCS anticipated holding tryouts July 6 through July 10, 2020, allowing students time to learn the routines. Middle school teams will begin after school resumes which is in line with what has been done previous years.

Ms. Allen added that an assumption of risk waiver will be added for athletic participation this year. Ms. Allen noted that conditioning would begin for two weeks and be held outside. At the recommendation of the South Carolina High School League, they will be in groups of 10 with one being a coach. These athletes will be at different locations or different fields for the first two weeks. All coaches and athletes will be screened before they are allowed to practice. HCS is taking the recommendation of Department of Health and Environmental Control, Centers for Disease Control, and South Carolina High School League, and practicing social distancing. Coaches are asked to wear masks and athletes are asked to wear masks when they are not actively participating in an activity. The conditioning will begin in 45-minute segments, and all proper sanitation procedures will be followed after each session. As a precaution, during the beginning stages of implementing this process, no parents/visitors are allowed to attend conditioning sessions. Ms. Allen noted that following the first two weeks, it is our hope to be able to get our athletes back into our gymnasiums and weight rooms.

Dr. Maxey then addressed the reopening of schools. Dr. Maxey noted that although HCS is awaiting final direction from the S.C. Department of Education,

HCS has put together a school re-opening committee consisting of representatives of district stakeholders: parents, teachers, students, staff members, and administrators. Dr. Maxey also pointed out that just today he had received a draft of the S.C. Department of Education's AccelerateEd Committee report and will begin reviewing it with staff. Once the state plan is finalized, HCS will incorporate the state's ideas and guidelines into the District's plan. Dr. Maxey remarked that one of our goals would be to keep the public informed once HCS had substantial information that can be shared through our website and social media. In the upcoming weeks, HCS will send out surveys to parents and employees seeking feedback concerning their experiences with distance learning as well as their thoughts for the upcoming school year. Dr. Maxey stated that this situation remains a fluid one, but he felt we would be looking at several options that could be a possibility for the District.
