College and career readiness will be measured using on-time graduation rate and composite SAT and ACT scores. The on-time graduation rate will meet or exceed the <i>District Consolidated Goals</i> baseline measures. The composite SAT and ACT will meet or exceed the <i>District Consolidated Goals</i> baseline measures. The district will allocate the necessary resources to ensure students are college and career ready.	Yes			

Interpretation: *I interpret this policy to mean...the college readiness for each year's graduating class of seniors is to be measured by the two primary college entrance exams (SAT and ACT) and that the composite scores for each of those will improve over time. Additionally, the passage rate on Advanced Placement (AP) exams will be included since those represent high school classes that can earn college placement credit. On-time graduation rate will also be reported when released by the S.C. Department of Education.*

Evidence of Status of Compliance:

SAT – SAT results released for the senior class of 2020 show that Horry County Schools (HCS) continues to outpace the national average, even with an increase in the percentage of seniors taking the SAT over the previous year's class.

The District's composite score, which includes Evidence-Based Reading and Writing (ERW) and Mathematics, is 1033, three points above the national composite score of 1030 and 14 points higher than the state composite score of 1019. In the subtest of Evidence-Based Reading and Writing, HCS students had an average score of 527, which is seven points higher than the national average of 520 and is eight points higher than the state average of 519. In mathematics, HCS students had an average score of 506, which is four points lower than the national average of 510 but seven points higher than the state average of 499.

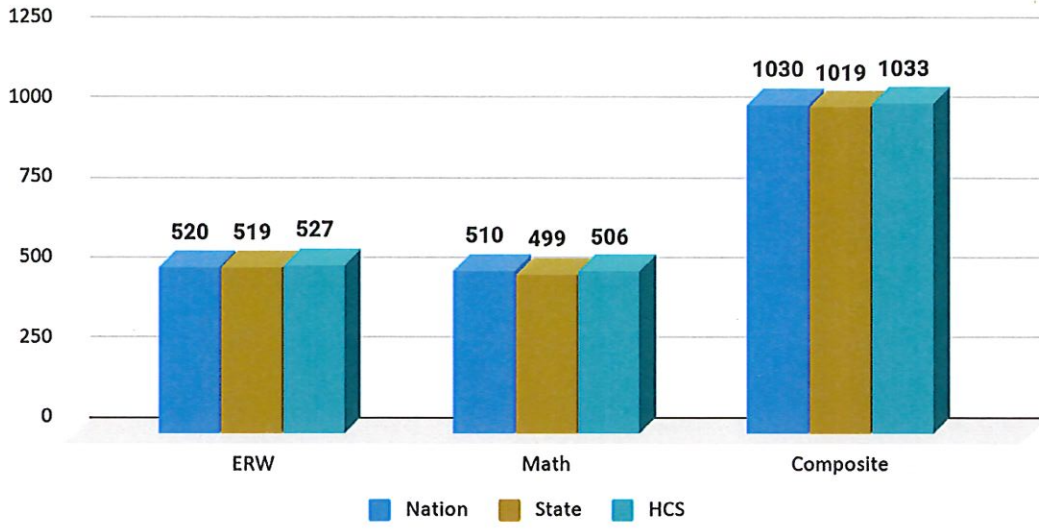
Newly released reports for 2020 include the first results of students who took the SAT during their third year of high school as an alternative to the ACT for state and federal accountability measures. Students were required to take one of these two tests as a measurement for college readiness, even if they did not plan to advance to higher education. Both tests were offered at no cost and were administered at school. Traditionally, SAT results reflect the performance of college-bound students who elect to take the test to meet college application requirements. Districtwide the scores of 1,593 seniors, 57.3 percent of the senior class, were reported in 2020 SAT results compared to scores of 1,382 seniors in 2019.

Five District schools have 2020 SAT composite scores that surpassed the national SAT composite score. They are The Academy for Arts, Science & Technology, 1168; Aynor High, 1089; North Myrtle Beach High, 1055; Carolina Forest High; 1052; and St. James High, 1044.

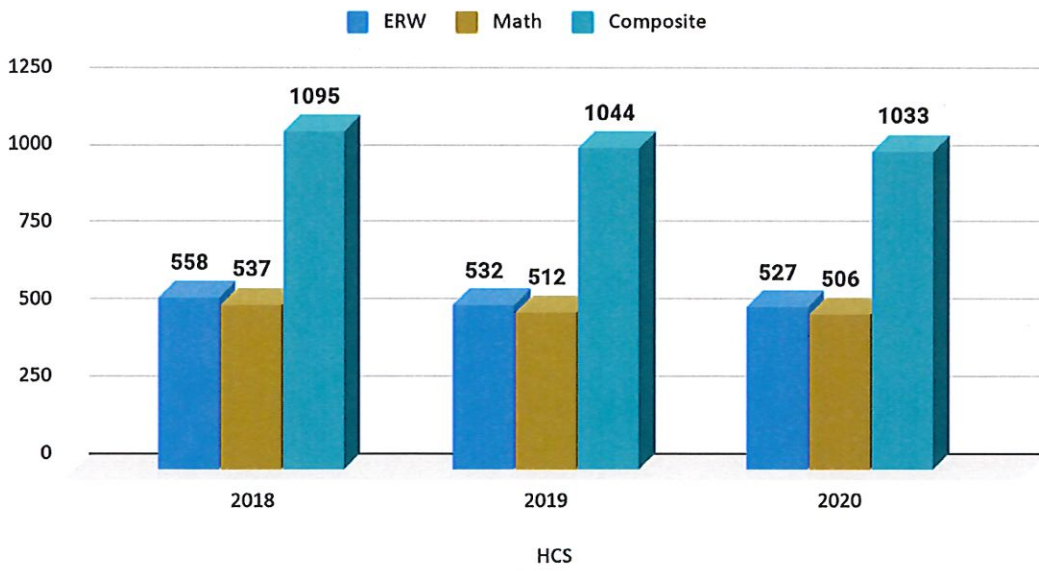

Evidence-Based Reading & Writing and Math



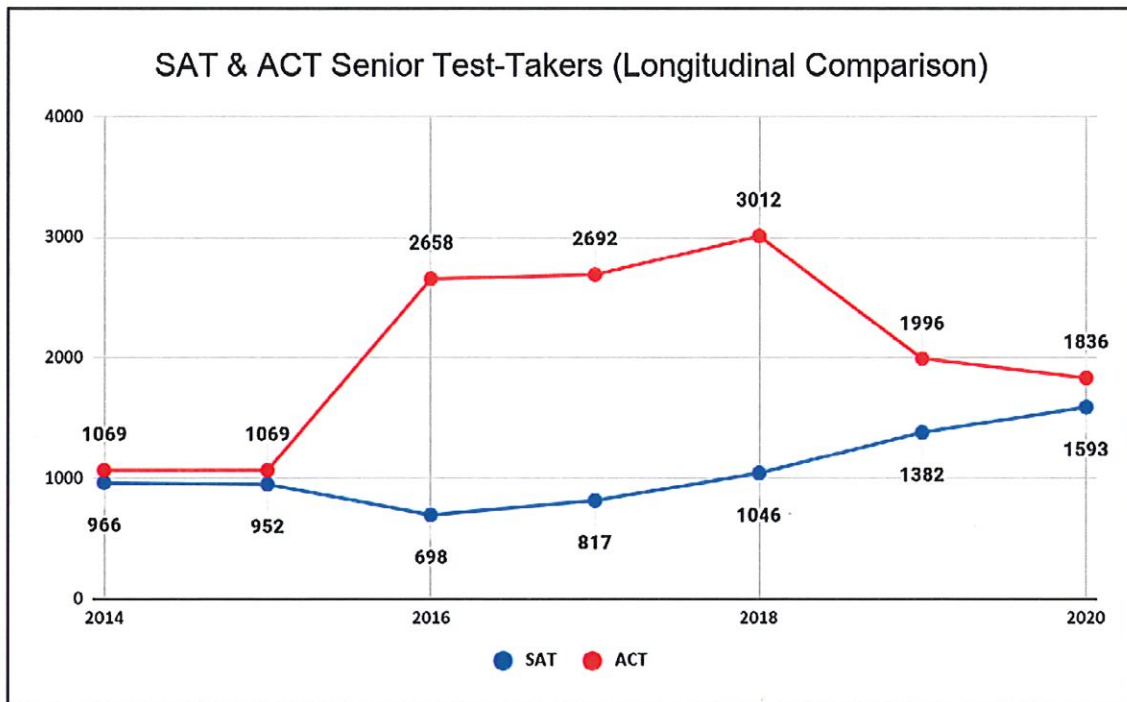
2018-2020 Comparisons

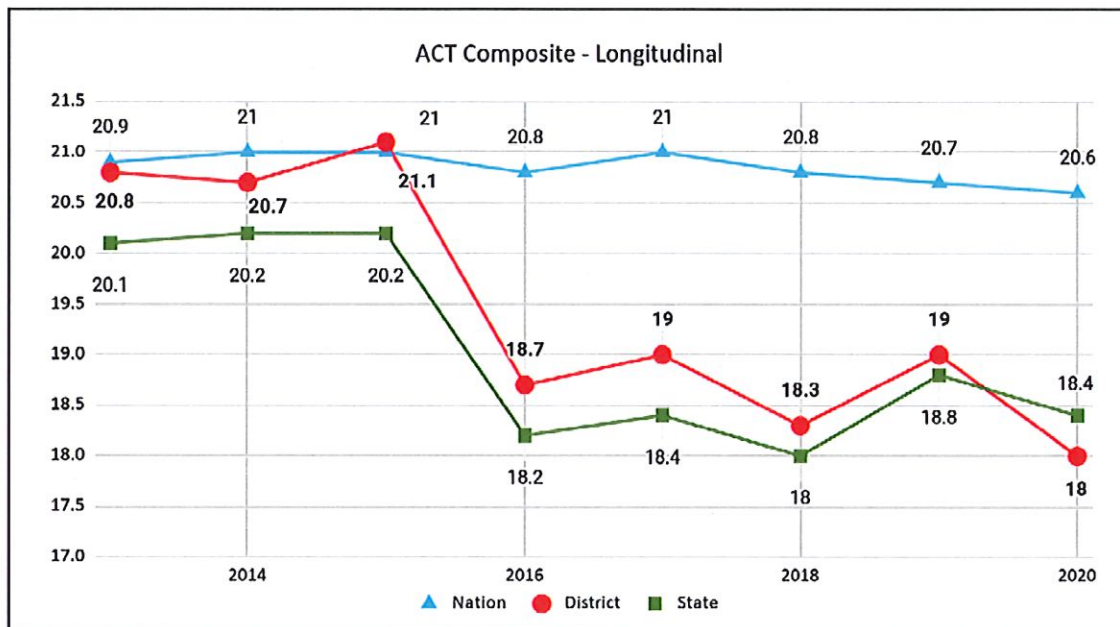

ACT – The ACT Composite score for the class of 2020 indicates a 1-point decrease to 18.0 similar to the state and national trends. HCS 2020 seniors dipped below the state average by 4 tenths of a point for the first time since

2013. The number of test-takers decreased by 160 students to 1836 from the previous year due to the state providing an opportunity for students to take either the ACT or SAT at no cost administered during the school day. District ACT scores are 0.4 points below the state average of 18.4 for public school students. The average HCS scores are as follows:

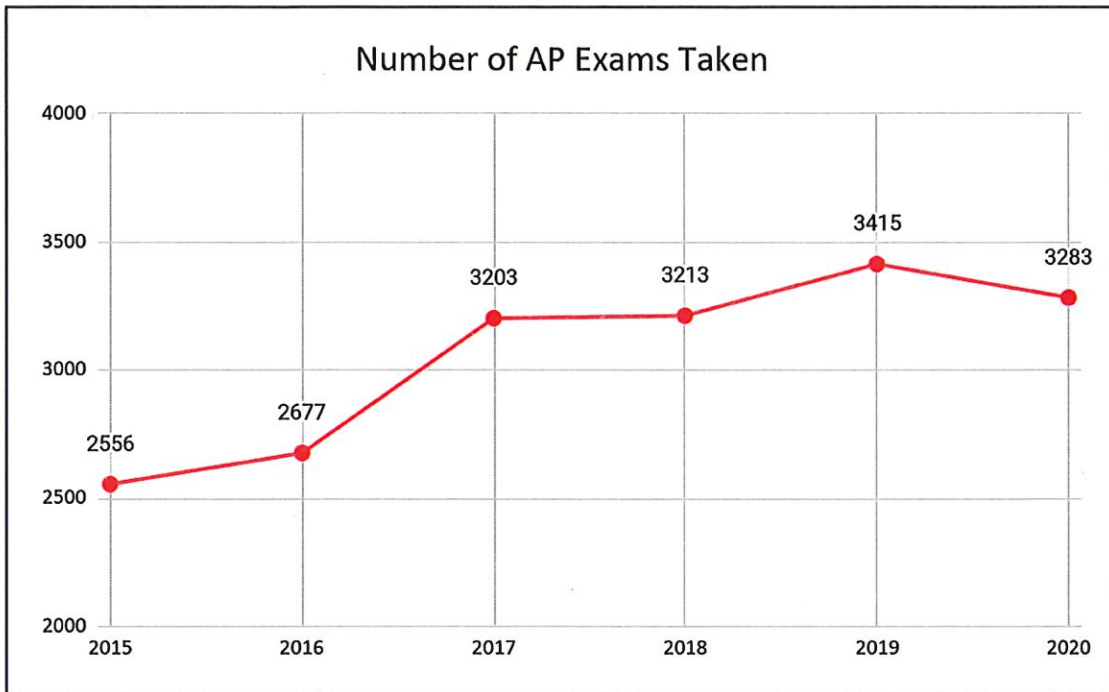


Advanced Placement (AP) – Newly-released data from College Board reports that HCS students increased their overall pass rate to 69.7 percent on Advanced Placement exams, outpacing the state average of 62.2 percent. Results for 2020 also show that HCS had a slight decrease of 3 percent in the number of students taking AP classes and a decrease of 3.8 percent in the number of AP exams taken.

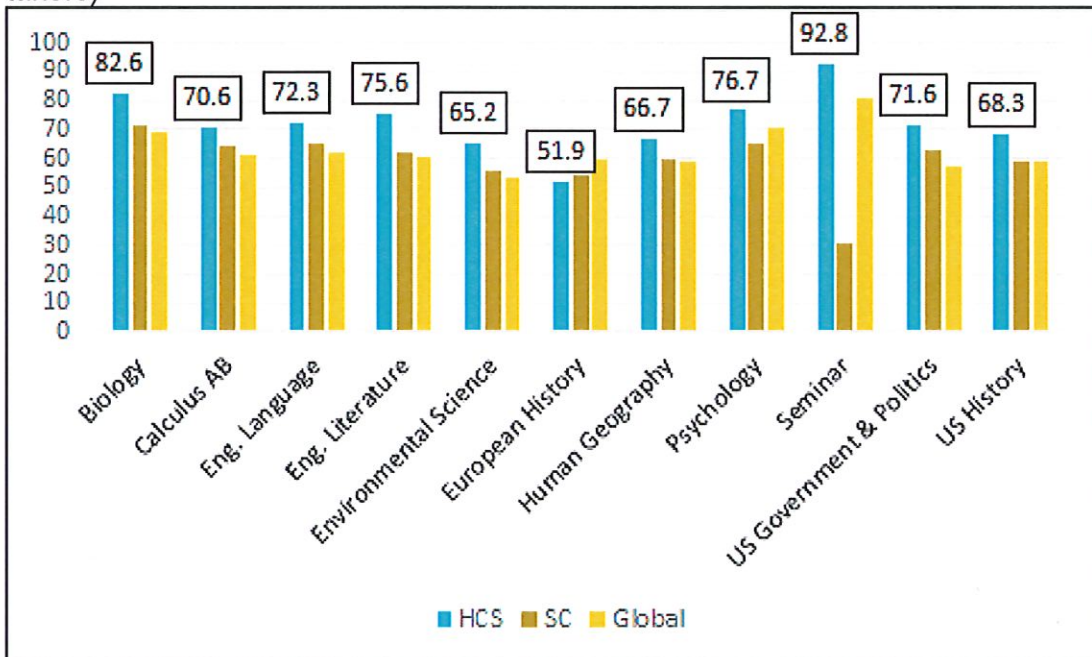
During the 2019-2020 school year, 2,145 HCS students participated in AP classes, slightly down from 2,213 students the previous year. For the school year ending in 2020, students taking AP classes took 3,283 exams, compared to 3,415 exams taken the previous year. The pass rate for AP exams is determined by scores of 3, 4, or 5. Students who earned scores of 3, 4, or 5 are also eligible to receive college course credit.

Five District schools had 2020 AP pass rates that surpassed the state average. They are The Academy for the Arts, Science, and Technology, 78.3 percent; St. James High School, 70.8 percent; Carolina Forest High School, 68.5 percent; Myrtle Beach High School, 68.3 percent; and Socastee High School, 67.3

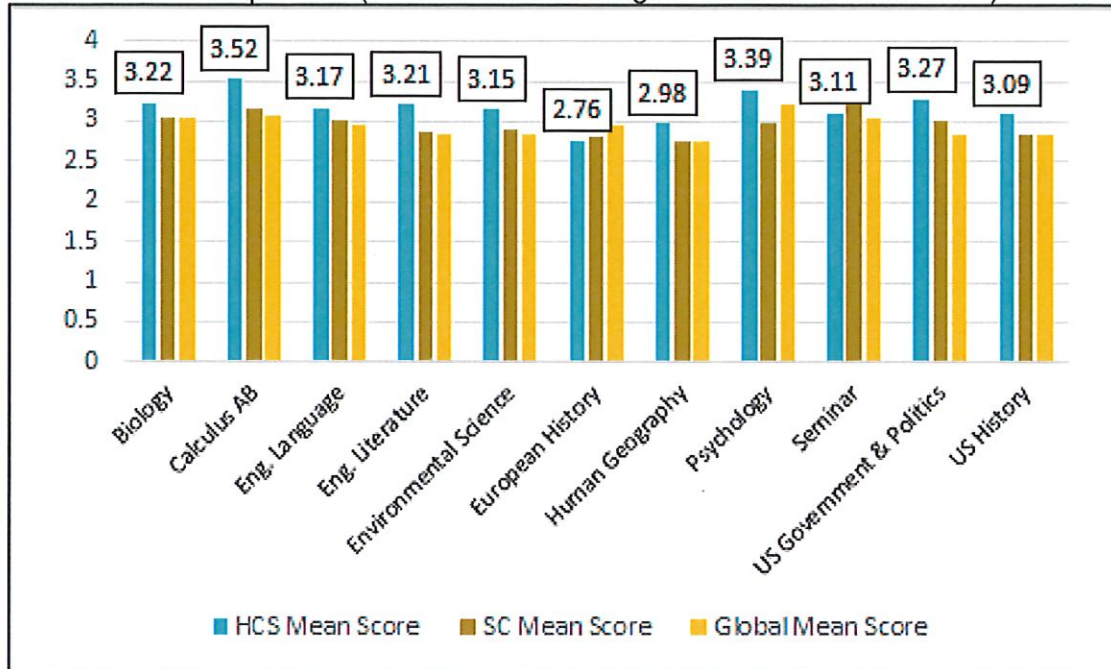
