Interpretation: I interpret this policy to mean...the college readiness for each year's graduating class of seniors is to be measured by the two primary college entrance exams (SAT and ACT) and that the composite scores for each of those will improve over time. Additionally, the passage rate on Advanced Placement (AP) exams will be included since those represent high school classes that can earn college placement credit. Ontime graduation rate will also be reported when released by the S.C. Department of Education.



SAT –The 2017 SAT Composite average for the senior class of 2017 is 57 points above the national average for public schools, and 44 points above the state average for public schools. This is HCS' largest margin above the national SAT


average in any year reported. Changes in the structure and reporting of SAT by College Board make prevent comparisons with last year. SAT has gone from prior years' three-part score (Critical Reading, Mathematics, and Writing on a 2400-point scale) to a two-part score (Evidence-Based Reading and Writing along with Math on a 1600-point scale) for 2017. The senior class of 2017 had 119 more test takers than in 2016. A total of 817 seniors took SAT, just over one-third of the class.




SAT and ACT Senior Test-Takers



ACT – The 2017 ACT Composite for the Class of 2017 improved by 0.3 points to 19.0, above the state average but below the national average. The number of test-takers increased by 34 students (to 2,692) from the previous year due to the state's census-testing of all students in their junior year – which gives all students in the senior class an ACT score. District ACT scores are 0.6 points above the state average. The average scores are:

Advanced Placement (AP) – The percentage of students who scored "3 or higher" (passing) their AP exams dropped by 4.1 points to 61.2% in 2017, but the number of students taking AP courses was at an all-time high – 2,075 students. The number of AP exams taken by Horry County Schools students increased by nearly 20% from the prior year. Horry County students' pass-rate on AP exams is higher than both the national and state average.
