As required by SC Law 30-4-80, local news media were informed of the date, time, place, and agenda of this meeting. Copies of the agenda were posted at the District Office and distributed to schools for posting.

1. OPENING NOVEMBER 7, 2016, AT 6:00 P.M. - CALL TO ORDER

Chairman DeFeo called the meeting to order at 6:00 p.m.

A. Invocation/Pledge of Allegiance

Mr. James offered the invocation and led the Pledge of Allegiance.

B. Approval of Agenda

Board Action: A motion was made by Mr. Cox and seconded by Mr. James to approve the agenda as presented. The motion carried unanimously. The Board Chair did not cast a vote on this item.

C. Approval of Minutes - October 24, 2016

<u>Board Action:</u> A motion was made by Ms. Graham and seconded by Ms. Morreale to approve the October 24, 2016, Board Meeting Minutes as presented. The motion carried unanimously and the Minutes were approved. The Board Chair did not cast a vote on this item.

Candidates for School Board

Mr. DeFeo asked if there was anyone who is running for the School Board who would like to introduce himself/herself to the audience. Ms. Shanda Allen, School Board Member Elect for District 11, introduced herself.

2. DISCUSSION

A. Monitoring Report: OE-6 Financial Administration

Mr. Gardner shared that a copy of the OE-6 Financial Administration Monitoring Report has been provided. He further stated that we believe we are in full compliance and evidence of such is included. Additionally, Mr. Gardner said he would like to focus on the fact that our last audit received an unmodified audit opinion, which is the highest opinion we could receive on a financial report. We expect to have the current financial report completed by the end of the month. The audit will be presented at the January 23rd Board meeting. The September 30th Financial Report was provided. Mr. Gardner offered to answer any questions regarding the Monitoring Report or the Financial Report.

B. Monitoring Report: OE-8 Communicating with the Board

Mr. Generette stated that OE-8 Communicating with the Board has been provided and offered to answer any questions.

Board Member, John Poston, joined the meeting at 6:04 p.m.

C. Monitoring Report: R-1 Literacy

Ms. Myrick shared that the Literacy Report, as well as data, has been provided and noted there is an error on the end of course testing slide. We will get that corrected. Ms. Myrick highlighted information from the Literacy Report and slides. Mr. James asked for a breakdown by school of the SC Ready ELA information.

D. Superintendent's Evaluation Process

Mr. DeFeo shared that Board members were provided an email with attachments earlier in the day. Board members were asked to review the information and let Mr. DeFeo know if you have questions or comments, or if questions for Dr. Maxey, you may contact him. Mr. DeFeo added that the Board will continue with the evaluation process.

E. Superintendent's Report

Dr. Maxey noted that tomorrow is Election Day and that South Carolina law prohibits holding a regular school day on Election Day, which is why this day was not used as a make-up day. Also, Dr. Maxey encouraged everyone to exercise their rights by voting tomorrow.

1) Recognition of HCS Employees – Hurricane Matthew Preparation and Recovery – Dr. Maxey shared that HCS employees did many things to make ready for Hurricane Matthew in terms of shelter preparation and recovery efforts. Our schools and the school system is very much a part of the Horry County community and we gladly step up and assist in a time of need. Earlier this afternoon, the Board members and Dr. Maxey had an opportunity to recognize our employees for the great job they did with helping out, and in many cases, left their own homes unattended, so they could do things for others. Dr. Maxey again shared how much our employees are appreciated and that our employees are our greatest asset. An appreciation meal was provided as a small token of that appreciation.

- 2) Extension of High School Football Season Hurricane Matthew The South Carolina High School League had to make some adjustments to fall season sports, to include football, for which the regular season was extended by two weeks. This Friday will now end the regular season, and one week from Friday, the playoffs will begin. The state championship games will be played on December 16 and 17, depending upon the classification.
- 3) Building Community Carolina Forest High School Carolina Forest High School is celebrating their 20th birthday. Dr. Maxey was recently invited to half-time to be acknowledged as one of the first principals of Carolina Forest High. The longest serving principal, Ms. Velna Allen, is in the audience. A homecoming parade was held, which is the first community-wide homecoming parade they have had to commemorate this special occasion. We congratulate them on their 20th year of existence.
