NEW CAROLINA FOREST AREA MIDDLE SCHOOL ATTENDANCE ZONE PROPOSAL

All of Carolina Forest Elementary (CFE), part of Ocean Bay Elementary (OBE), and part of River Oaks Elementary (ROE) would attend the New Middle School. The remaining parts of OBE and ROE would attend the current Ocean Bay Middle School. Specific areas to attend the New Middle School from ROE include Legends, Burcale Rd area, Sago Plantation, Pine Island, and Emerald Lakes. Specific areas to attend the New Middle School from OBE include Summerlyn, Plantation Lakes, and Waterbridge. Please see map for details.

2015-16 Residing Student Data

Estimated 506* Residing Students (current grades 4-6) from CFE Attendance Area, 225* Residing Students (current grades 4-6) from ROE Attendance Area, and 83* Residing Students (current grades 4-6) from OBE Attendance Area. Total estimated 2015-16 Residing Students to move would be 814*.
