- OSF Approval of structure and mechanical penthouses CFMS, SES, SJIS, MBM

Pending

- LD permit for the MB site is contingent upon CAB approval;
- CAB submittal March 4th, CAB meeting March 17th
- Early site package submittal in March for SMS; anticipating May 1 OCRM approval
- Encroachment permit from County for temp access road to start timbering
- SCDOT for SMS has been verbally approved
- OCRM and Horry County final site packages will be submitted in late March for approval
- Water and sewer drawings will be submitted to DHEC in late March for final approvals




