### 2015 Middle School Summer School Program

#### OBJECTIVES:

The objectives of the middle school summer school program are as follows:

- ⇒ To allow students in grades 6-8 the opportunity to make up course work that was not successfully completed during the school year.
- ⇒ To allow students in grades 6-8 the opportunity to make up course work that was not successfully completed due to excessive absences.

#### SCHEDULES:

**Students:** Classes will be held on Monday, Tuesday, Wednesday, and Thursday and will run approximately from 7:45 a.m. until 1:45 p.m. The daily schedule will consist of six hours including breaks.

**Teachers:** 6 hours per day

#### TUITION FEES:

- No fees for in-district students.
- \$200 per course for out-of-district students.

#### COURSE REGISTRATION PROCEDURES:

Summer School registration forms will be available in the guidance office after May 22, 2015. These forms should be secured from a counselor, completed by the student or parent/guardian, **signed by a counselor or principal**, and returned to the principal or his/her designee by Monday, June 8, 2015. **Final registration will be held at each center on Monday, June 15, 2015.** Middle school courses will be offered at the middle school centers listed above.

Registration will not be held after Monday, June 15, 2015. Summer school directors and the

executive director for middle schools will determine whether or not demand is sufficient to offer a course. **Fees for out-of-district students must be paid by Monday, June 15, 2015.**

#### REFUND POLICY FOR OUT-OF-DISTRICT STUDENTS:

If a refund of fees becomes necessary, the following policy will be in effect:

- If a student voluntarily drops out of the program on or before June 30 5/6 of the tuition fee will be refunded.
- If a student withdraws or is dismissed from the program after June 30, there will be no refund.
- No refund will be given to students who drop out because of failure to meet attendance requirements as specified by the Defined Minimum Program of the Horry County Schools or who fail to meet academic requirements to earn a satisfactory grade on the course(s) taken.

#### BUSING

Transportation to summer school sites is available at no charge to in-district students. Community bus stops are used during summer school. Contact your school to find the stop closest to you.

#### ATTENDANCE SCHOOL

Program offered for any student in grades 6-8 who needs to make-up days for promotion. To qualify, a student must have a passing average in the class.

**Location:** All summer school sites will offer the program.

**Assignment:** Students will be assigned make-up time based on the number of unlawful absences in excess of 10 days.

Number of Days	Make-up Time
1-5	1 week
6-10	2 weeks
11-15	3 weeks
16+	entire summer school

**Dates:** Students should begin Attendance School on day one until make-up days are completed.

**STANDARDS:**

The summer school program will follow the guidelines of the Horry County Schools curriculum standards.

**MAKE-UP WORK:**

Although no tuition is charged for in-district students, attendance is required for all classes until the summer session ends. Any work missed due to absences must be made up or credit will not be granted. **Students will be charged a fee of \$5.00 an hour to make up time for unexcused absences.** The time will be based on quarter hour increments and can be made up on Tuesday, Wednesday, or Thursday at assigned times during the regular summer term. **A student with more than four hours of excused absences will be required to make up work at times designated by the center directors.**

Students must make up work within five (5) school days after being absent.

**No make up work will be permitted after the last day of summer school.**
